GLS Signs – The Board is exploring the cost of one, possibly two GLS signs. The Pileri's have volunteered to have one place on their property on the non-lake side of M25. More to follow once estimates are received.

Future Beach Erosion/Damaged Jetty's– Joe is renewing permit, which is timely. Once the permit is obtained it is good for 5 years. Our Beaches are low right now; we are not currently under a time constraint. No actions will be taken this year; however, we are exploring all options to prevent future erosion. More to follow on this topic as further research is done.

be exploring all options to prevent future beach erosion. Our permit has expired, and Joe Rotellini is in the process of obtaining a new one. Likely we will not perform any action this year, as the permit takes time and our beaches are very low this year; it is not urgent. We need to gain approval from Eagle and the Engineering Corp of Engineers for any actions we are considering taking. In addition, no action will be taken until the action is approved by our Membership. Joe will continue to work on the permit and keep us abreast of progress, options, and potential actions.
